

TYPES OF CHILD CARE *at a glance*

Care Setting	Maximum # of Children	State Certification Required
Relative Care*	3	No
Friend/Neighbor Care	3	Yes, if receiving subsidy payments
Family Child Care Home	6	Yes
Group Child Care Home	12	Yes
Child Care Center	7 (minimum)	Yes

*Relatives are biologically-related (to child) as an aunt, uncle, sibling, grandmother/father, great-grandmother/father; 18 years+, and do not live in the home. Background clearances are required to receive subsidy payments.

STAFF-TO-CHILD *ratios*

Age Levels	Staff	Children
Infant (0-12 mos.)	1	4
Young Toddler (12-24 mos.)	1	5
Older Toddler (25-36 mos.)	1	6
Preschool (37 mos.-Entering K)	1	10
Young School-Age (K-3rd gr.)	1	12
Older School-Age (4th gr.-15 yrs.)	1	15

Note: In a Family Child Care Home, no more than **2 infants** may be in the provider's care at the same time.

IMPORTANT THINGS *to consider...*



Home providers may have early morning, **2nd & 3rd shift hours.**



Verify the provider's **transportation options** for before/after school care.



Place your child on **waiting lists** as you continue your search for immediate care.



What is their **Keystone STARS** level? The more STARS, the higher quality.



Do they serve healthy meals through the **Child & Adult Care Food Program**?



Consider **back-up care** in the event the provider you choose is sick or closed.

QUALITY CARE *checklist*

Use this checklist when visiting and interviewing providers.

PROVIDER **Child Supervision**

- 1 2 3
- Staff-to-child ratios are maintained (see chart on reverse)
 - Children are supervised at all times (indoors/outdoors; awake/sleeping)
 - Caregivers are attentive to children's needs
 - Children seem happy and engaged

PROVIDER **Health & Safety**

- 1 2 3
- Home settings are safe, clean and child-friendly
 - Medications are labeled and out of children's reach
 - First Aid supplies are maintained
 - All caregivers are Pediatric First Aid and CPR certified (ask to see certification cards)
 - Meal preparation, bathroom and diapering areas are clean and sanitized
 - Toys are clean, safe, age-appropriate and within reach of the children

PROVIDER **Program Management & Learning Opportunities**

- 1 2 3
- Participation in Keystone STARS quality improvement program
 - Caregivers have experience/education in early childhood development
 - Variety of books, blocks, puzzles and toys to prepare children for success in school
 - Parent involvement and parent/teacher communication encouraged
 - Nutritious meals and snacks are served

Parent references ✕ Holiday schedules ✕ Sick policies ✕ Rates and other fees
Transportation (school, field trips, etc.) ✕ Staff's participation in ongoing training
